## Car Seat and Portable Crib Program

Congratulations! We hear you're expecting. We encourage you to see your Obstetric (OB) Provider\* to begin prenatal visits as soon as you become pregnant.

If you are a Blue Cross Community Centennial<sup>™</sup> member who is pregnant, you can receive a car seat and portable crib from Blue Cross and Blue Shield of New Mexico (BCBSNM) at no charge.\*\*

## **How to Get the Car Seat**

To get the car seat, you will need to:

- Participate in the Special Beginnings<sup>®</sup> maternity program; there is no charge to participate in this program.
- See your OB Provider for 8 prenatal visits.

## **How to Get the Portable Crib**

To get the crib, you will need to:

- Participate in the Special Beginnings maternity program.
- Visit your OB provider for your first prenatal visit in the 1st trimester or within 42 days of enrollment in Blue Cross Community Centennial.
- Call BCBSNM at 888-421-7781 (TTY: 711) to learn more about the Safe Sleep Program.

Keep track of your visits on this form. Once complete, you (or your OB Provider) need to fax the form to **505-816-3854**. If you cannot fax the form or have questions, call BCBSNM Special Beginnings at **888-421-7781**. If you are speech- or hearing-impaired, call **711** for TTY service.
